#### Local Priority: Action plan implementation

What has happened in school to make the impact? e.g. displays, workshops, small groups, training, resources

- 1. We have investigated a wider range of physical activity suitable for physically disabled pupils, visited Victoria with a report on its implications brought back by senior TA, liaised with Thomas Hardye and are planning a range of sports appropriate for physically disabled pupils to join in alongside able bodied children. We have also arranged for two paralympians to visit the school to talk and show their sports. Commentary: Physically disabled children enjoy PE and now have a choice of activity when mainstream lessons are not suited to their needs. They have enjoyed an all age disabled sport day at Thomas Hardye and we are looking into more regular provision of disabled sports throughout the school year, for example during our next Olympics Week. Hydrotherapy and swimming are particularly effective in aerobic provision.
- 2. We have improved our Huff & Puff equipment and extended its use to more playtimes. Commentary: sample of children enjoy Huff & Puff, recognise its impact on their physical activity and say it helps to make playtimes fun.
- 3. We have talked with all children but especially those entitled to Free School Meals about the sorts of clubs they would like to attend and tried to provide them by staff or via the older pupils in Year 4. There are a number of aerobic lunchtime dance clubs that are very popular. Commentary: All children entitled to free school meals are attending at least one club. This will be continually monitored to ensure involvement, especially in those clubs which are physically active.

#### **School Priority: Action plan implementation**

What has happened in school to make the impact? e.g. displays, workshops, small groups, training, resources

Commentary: Schemes of work have been reviewed to ensure that lessons start with aerobic activity and that the importance of exercise for health is stressed regularly.

Commentary: SEN governor conducted a parental survey about access to out of school activities for pupils with a physical disability. This showed that there are a number of barriers to access, including cost, availability, 1:1 support, transport. The outcomes of this survey have been shared with Vikki Abbot and Jenny Barrett (Locality Early Intervention Team) as the school feels these issues are beyond its capacity to address.

Commentary: termly AIMS meetings have reviewed access to full range of programme necessary to meet the needs of physically disabled pupils and found that children are accessing these much more systematically and consistently.
