"We aim to raise the attainment of disadvantaged children through high quality teaching and by meeting individual needs"

At The Prince of Wales School, our Pupil Premium Strategy for 2025/2026 builds on our strong foundations of inclusion, belonging, and pastoral care. Following a year in which disadvantaged pupils continued to thrive socially but not yet academically, our renewed approach prioritises the use of assessment, precision teaching, and emotional literacy to drive measurable gains in attainment.

Every child is recognised as a unique individual, and our mission remains to provide first-hand learning experiences that nurture resilience, independence, and a love of learning. We will continue to use our Learning Powers and Therapeutic Thinking framework to develop positive attitudes, confidence, and self-regulation — ensuring that emotional readiness leads directly to improved learning outcomes.

Community and culture remain central to our vision. Through engagement with music, the arts, and the local community, we will ensure that all pupils, including those eligible for Pupil Premium, experience rich, inspiring opportunities that build self-worth and ambition. Our goal is for every disadvantaged learner to leave our school achieving in line with their peers — academically confident, emotionally secure, and ready for the next stage of their education.

N.B - Despite the school's continued commitment to inclusion, enrichment and emotional well-being, 2024/25 outcomes show that these strengths have not yet translated into improved academic attainment for disadvantaged pupils. This reflects a wider national challenge, with disadvantaged attainment gaps widening post-pandemic, particularly in early reading and phonics. The school's 'Outstanding' judgements for Behaviour, Personal Development and Early Years (Ofsted, June 2025) demonstrate that the foundations for success—engagement, attendance and belonging—are securely in place. However, academic equity remains the key priority moving forward. In 2025/26, the focus will be on ensuring that high-quality teaching, early intervention and precise use of assessment data drive rapid gains for disadvantaged learners, supported by robust monitoring through pupil progress reviews and strengthened teacher accountability.

	We celebrate and welcome differences within our school community. The ability to learn is underpinned by the teaching of basic skills, knowledge, concepts and values. We constantly provide enhancement opportunities to engage learning and believe that childhood should be a happy, investigative and enquiring time in our lives where there are no limits to curiosity and there is a thirst for new experiences and knowledge.
	We use Learning Powers to promote positive attitudes to learning which reflect the values and skills needed to promote responsibility for learning and future success. Community involvement is an essential part of our curriculum as we celebrate local traditions, learning new skills to enable the children to take an active role in events throughout the year.

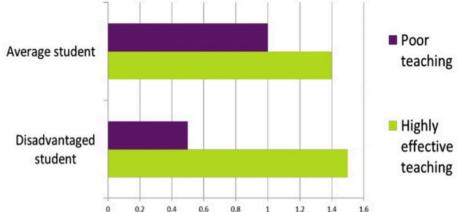
Further information (optional)

Background -

Following the Headteacher's attendance of the 'Dorset Pupil Premium Conference', the Senior Leadership Team have reflected considerably on their approach to the spending of Pupil Premium Funding.

At the conference, Sir John Dunford (Formally National Pupil Premium Champion) advocated for the importance of 'relentlessly focusing on the quality of Teaching and Learning'. Sir John made reference to the Sutton Trust (2011) research -
