Bikeability is the cycling proficiency of the 21st Century, designed to give the next generation the skills and confidence to ride their bikes to the Government approved national standards for cycle training. More information is available on the website www.bikeability.org.uk

During Level1 Bikeability training, children will learn to control and master their bikes. The training takes place in an environment away from cars and traffic, usually in a playground or closed car park.

To confirm a place for your child(ren), please return your completed consent form together with cash payment of £15 per trainee to the school office asap. Unfortunately it will not be possible to offer places to trainees unless payment has been received before the start of the course.

Once your child has completed Bikeability, they will receive a badge, certificate, and a report detailing progression to the next level and/or any further practise required. Level 2 (training on quiet roads) is normally delivered from year 5, and Level 3 (training on busy roads with complex junctions) from year 6 where a high standard at Level 2 achieved. Both Levels are currently Government funded so FREE of charge!

Checklist for training

Firstly you need to ensure that your child's bike is **roadworthy**. You must be prepared to organise and pay for any repairs to make your child's bike roadworthy. The first step to safer cycling is to ensure that bikes are regularly checked and maintained & all children who will be taking/have taken part in Level 1 Bikeability should be familiar with this by the end of the course. Please check the following prior to training:

- Saddle and handlebars correctly adjusted & not over extended
- Brakes fully functioning
- Tyres properly inflated & checked for punctures
- Security of fitted parts
- General condition of bike & components

Please note that the instructor reserves the right to refuse to take out any child whose cycle is not the correct size or considered to be un-roadworthy

It is also important that your child is dressed appropriately for training & able to carry drinks, snacks, & any equipment safely:

- Weather waterproofs plus a change of clothes if raining, gloves & several layers of clothes when cold, sunscreen when hot
- Drinks bottled water always required whatever the weather
- Cycle helmets correct size and fit with recognised test standard such as the BSI Kite Mark, ANSI or American Snell B. 95, European CE Mark
- Trousers/tracksuit bottoms close fitting or snapband/bicycle clip required
- Footwear closed heel and toe, long laces not recommended
- High-visibility vests are highly recommended & will be provided during the course
- Rucksacks/backpacks required if bikes not fitted with bottle cage & panniers, etc, for Levels 2 & 3
